I will:

- Check my emails and the school website regularly. Our main form of communication with parents is via email.
- Ensure I have logged into -Arbor and check the app regularly. This is how we communicate with parents/carers about rewards, homework and detentions.
- Inform school immediately of any changes in medical issues
- I will ensure that my child's Parent Pay account is always in credit; ensuring that they are able to purchase school dinners (if not eligible for FSM), buy replacement equipment if needed, contribute to the cost of materials for lessons
- Inform the school immediately of any changes in address, email address or contact numbers. I will ensure the school has at least 2 contacts for my child
- Support the school's Behaviour Policy. This includes making transport arrangements if your child has been issued an after-school detention or an RFI sanction at another school. You will be notified via ~~Class Charts~~ Arbor if your child had received any sanction
- Ensure that they wear the correct uniform and will support the school in applying consequences for failure to wear it appropriately – this includes PE kit
- Ensure that my child is fully equipped to support their learning as per the list in the student planner and on the school website
- Support the school's mobile phone policy – mobile phones must be turned off before entering the building. Your child's phone will be confiscated if they are seen with it switched on/using it. Parents/Carers or a responsible adult will be expected to collect any phone that is confiscated.
- Ensure my child only wears one pair of studded earrings (5p coin size) and that clear retainers are worn for facial piercings. I will ensure that my child removes ALL piercings when taking part in PE. No other jewellery other than a watch and one ring is permitted.
- Regularly check my child's planner. I will support the replacement cost of £3 if my child loses it.
- Aim to make sure that my child attendance school regularly and on time in line with the school expectation of 96.5%, aiming to secure 100% attendance where possible,
- I will adhere to the procedures that the school has in place in reporting any absence my child may have. I will inform the school, before 8:00 am, if my child will be absent that day
- I am aware that as a parent, I am responsible for making sure that my child attends school regularly and I am aware that I may be fined by the Local Authority if my child's attendance doesn't meet expectations
- I have read and understood the Attitude to Learning Grades and will support the school to ensure that my child's attitude to their learning meets the school's expectations
- Keep the school informed about any issues which may affect their leaning
- Support my child with their homework
