Dear Parent/Carer

You will be aware the government has instructed us to close our schools to pupils after tomorrow. We must comply with this instruction, albeit with a heavy heart. We feel great sadness for our pupils and students who have worked so hard this year, particularly those who have been preparing for public examinations. We will do everything we can to help them, both practically and emotionally in the remaining day or so.

We are still waiting for details from the Department for Education about some important matters. They will tell us tomorrow about the arrangements for assessing pupils who were due to sit GCSEs, A' levels or other qualifications this summer. We will share our plans and any relevant guidance as soon as we can and will do all we can to ensure pupils are not disadvantaged by these events.

You will also be aware that schools will remain open to some children. You may continue to send your child to school if you are a key worker and the government will issue further guidance about this category today. We already know it will include parents working in the NHS, schools, food delivery and other essential services but are still waiting for the definitive list. We will circulate the list of qualifying professions as soon as we receive it.

We also know we will be asked to provide free school meals where we can. I have made the decision we will extend this offer to any family experiencing financial hardship, so please let us know if you will need a meal for your child in the coming weeks. If your circumstances change, please get in touch with us as soon as possible. We will share how to claim the meal after the government issues further guidance.

Pupils with special educational needs will also be able to attend school next week. Again, please let us know if you will need a place.
